Being a by-law to impose fees for services provided by the municipality.

WHEREAS The Municipal Act, R.S.O. 2001, Section 391(1) permits municipalities to pass by-laws for imposing fees or charges on any class of persons for services or activities provided or done by or on behalf of it and;

WHEREAS the Council of the Council of the Township of Madoc deems it necessary and expedient to levy charges for certain functions performed by the municipality;

NOW THEREFORE the Council of the Corporation of the Township of Madoc HEREBY ENACTS AS FOLLOWS:

- 1. THAT the charges for municipal services provided as set out in Schedule 'A' attached to this by-law shall apply upon the passing of this By-law.
- 2. THAT all monies derived from these fees or charges shall become part of the general revenues of the Corporation of the Township of Madoc.
- 3. ANY By-law inconsistent with the provisions of this By-law is hereby repealed.
- 4. THAT this by-law shall come into force and take effect upon the date of its passing.
