Start date: July 1, 2020

End date: July 31, 2020

For the month of July, our Household Hazardous & Electronic Waste Depot located at 75 Wallbridge Cres in Belleville, the hours of operation will be:

- Tuesdays: 1PM – 6PM
- Wednesdays and Thursdays: 9AM – 4PM
- Every Saturday (in July only): 9AM – 4PM

Please note: all Mobile Events have been CANCELLED for the month of July:

- CANCELLED: Saturday, July 11 – Madoc Village
- CANCELLED: Saturday, July 18 – Frankford

Starting August 1, our Mobile Events intend to resume the regular schedule barring any changes in emergency orders:

- Saturday, August 1 – Belleville Depot
- Saturday, August 8 – Picton
- Saturday, August 15 – Tweed
- Saturday, August 22 – Tyendinaga
- Saturday, August 29 – Marmora & Lake

Anyone visiting the Depot MUST follow these health and safety guidelines:

- If you are sick, do not visit the Depot. If you are exhibiting symptoms of COVID19, you will be instructed to leave the property.
- Wear a mask if possible, as all of our staff will be wearing one.
- Place all of your household hazardous or electronic waste material(s) in the cargo area of your vehicle. If the material is not in the cargo area, you will be asked to exit the property to place the material in your cargo area before returning to the depot.
- If you refuse, your material will not be accepted, and you will be instructed to leave the property.
- We will NOT be doing any broken blue box exchanges or purchases at this time. Please refer to our ‘Get a Blue Box‘ webpage to see where you can exchange or purchase blue boxes.
- If you are a business, non-profit or agricultural business, please call us to discuss the disposal of your materials at 613-394-6266 OR Toll-Free: 1 (800) 210-0762
- Be aware that wait times may be longer than normal. If you can, plan your visit for later in the season. **Please be patient!**
